“The category and corresponding amount of the annual dues shall be determined by the annual dollar volume of security officer revenues derived from all controlled subsidiaries and divisions operated domestically based on the company’s last tax reporting year. "Security officer revenues" shall be defined as all traditional forms of business performed domestically (inclusive of U.S. territories and possessions), including, but not limited to uniformed security officers, plainclothes security officers, street patrols, motorized patrols, security reception services, nuclear facility security officers, investigative services, etc., without regard to whether such officers are armed or unarmed. The categories and base dues shall be as determined by the Board of Directors from time to time.” (NASCO Bylaws Article V. Section 1)

I am aware that our company is in Category _____ for dues purposes, and that our company will be responsible not only for annual dues, payable in advance, but also for a share of approved assessments for state or federal legislative expenses described in the By-Laws; and for such other financial obligations as may arise according to the By-Laws.
